## **Bid Bulletin No 2**

# **Supply and delivery of Medical Monitors and Pulse Oxymeters**

### **IFB No: 2021/MED/04/MO**

#### Question 1:

Please, clarify if we can participate for items No 2, 3, 4 and 5 only, since we do not offer item 1.

#### Answer 1:

Interested bidders should submit quotation for all required items (No.2 to No.5) as per revised Bidding Documents “(Revision No.1) Bidding Documents - Medical Monitors and Oxymeters\_2021.MED.04.MO” and in accordance with the Addendum No.1. The selective/partial bidding is not allowed. However, Bidders may participate as members of a joint venture of two or more firms as partners. Kindly check Addendum No.2 which has been issued for this purpose.

#### Question 2:

1) Η εγκατάσταση που θα πραγματοποιηθεί? σε ένα σημείο όλα ή θα πανε σε διαφορες περιοχές της Ελλάδας? ρωτάμε γιατί πρέπει να οργανώσουμε το τεχνικό τμήμα αντίστοιχα, και βεβαια τις μεταβάσεις. Δεν θα υπάρξει προσθετη χρεωση για εσας, αλλα επειδή πρέπει να προσφέρουμε τιμή fix, θελουμε να κανουμε τους υπολογισμους.

2)η επιδειξη θα γινει ταυτόχρονα με την εγκατάσταση, ή πρέπει να γινει μετάβαση τεχνικων αλλη ημέρα?

3)Τι είναι το ADVANCE PAYMENT SECURITY που πρέπει να εκδώσει η τράπεζα μας? Δεν είναι η εγγυητική καλής εκτέλεσης. Πότε πρέπει να γίνει? Σε ποιον θα πρέπει να δοθεί αυτή η εγγυητική? Θα θέλαμε μια πληροφόρηση.

4) Βλέπουμε ότι είναι παράδοση DAP. Τα υλικά θα τιμολογηθούν χωρίς ΦΠΑ, επομένως θα πρέπει να εισαχθούν χωρίς να προκαταβάλουμε το ΦΠΑ. Θα μπορέσετε κατά την εισαγωγή να κανετε σχετική επιστολή στο τελωνείο, όπου θα συνοποβάλλουμε το τιμολόγιο μας που θα αποδεικνύει ότι κι εμεις σας τα παρέχουμε χωρίς ΦΠΑ ? Εχουμε κάνει πολλές εισαγωγές για αντίστοιχες περιπτώσεις χωρίς ΦΠΑ, απλά θα θελαμε να επιβεβαιώσουμε ότι προβλεπεται να κανετε κι εσεις τις αντιστοιχες ενέργειες, ώστε να μην υπάρξουν καθυστερήσεις στον εκτελωνισμό. Τα τελωνειακά έξοδα και η συγκεντρωτική μεταφορά ώστε να παραδοθούν στο σημείο που θα μας υποδείξετε, θα βαρύνουν την εταιρία μας, σωστά?

5)η παράδοση τους από εμάς , θα γίνει συγκεντρωτικά σε ένα σημείο? αυτό το σημείο είναι στην Αθήνα ή αλλού? αν θα διανεμηθούν κατόπιν αλλού, θα φροντίσετε εσεις για την αποστολή τους στα σημεία εγκατάστασης?

Answer 2:

- 1) As per Bidding documents the delivery place is the Warehouse in the region of Attica, Athens Greece.
- 2) The installation will be done at a later stage.
- 3) Your bid should be accompanied by the relevant bid security furnished in accordance with ITB Clause 17 as stated in the clause 10 of the bidding documents. The ADVANCE PAYMENT SECURITY (Bank Guarantee) will be submitted by the awarded vendor in case of request for advance payment.
- 4) As per clause 27.3 of the Bidding Documents IOM's evaluation and comparison of Bids shall be between the DAP price of the goods offered from within IOM's Mission country, such price to exclude customs duties and VAT payable against the DAP price of the goods, excluding customs duties and VAT at the destination country offered from outside IOM's Mission country. As per clause 12.2 For goods and services that the Bidder will supply from within or outside IOM's Mission country, the prices shall be quoted in DAP, exclusive of VAT.
- 5) As per Bidding documents the delivery place is the Warehouse in the region of Attica, Athens Greece. The installation will be done at a later stage.

Question 3:

- 1) About Clause 14, points 14.3.b, 14.3.c, 14.3.d and 14.3.k (documents from Public Authorities) should be also in English language or are they acceptable only in Greek language?
- 2) About Section II. Schedule of Requirements, the Delivery Place that it is referred is "Warehouse in the region of Attica, Athens Greece.". All the offered items will be delivered to one Warehouse? Please clarify us the final destinations.
- 3) According to the terms of the Tender IFB No.: 2021/MED/04/MO, it is clear that nowhere is referred that should be submitted bid for all required items. We would like to clarify why IOM does not allow selective/partial bidding of items? If IOM accepting offers of some items, will achieve the most favorable solution in accordance with Letter of Invitation (page 3 of the Bidding documents).

Answer 3:

- 1) All IOM forms prepared shall be submitted in English. Any other supporting documentation which is requested by the bidding documents will be deemed to be accepted also in Greek language.
- 2) As per Bidding documents the delivery place is the Warehouse in the region of Attica, Athens Greece. The installation will be done at a later stage.
- 3) Interested bidders should submit quotation for all required items (No.2 to No.5) as per revised Bidding Documents "(Revision No.1) Bidding Documents - Medical Monitors and Oxymeters\_2021.MED.04.MO" and in accordance with the Addendum No.1. The selective/partial bidding is not allowed. However, Bidders may participate as members of a joint venture of two or more firms as partners. Kindly check Addendum No.2 which has been issued for this purpose.

Question 4:

- (i) Are we allowed to propose multiple options to one product, as multiple models could meet the technical specifications
- (ii) Would it be possible to move the closing date to 27/04/2021 for all the tenders, as it would provide us with sufficient time to submit fully compliant bids with courier service and also to furnish the required bid bonds with our bank
- (iii) Alternatively also let us know if there is any intention to allow bid submission via e-mail and only bid bond submission in hand / via courier

Answer 4:

- (i) Interested bidders may only submit one quotation. If an interested bidder submits or participates in more than one quotation such quotation shall be disqualified. Kindly check Addendum No.2 which has been issued for this purpose.
- (ii) In order to allow prospective bidders reasonable time in which to take the amendment into account in preparing their bidders, IOM is extending the deadline for the submission of bids. Kindly check the Extension for Submission of Bids which has been issued for this purpose.
- (iii) As per Bidding Documents, Bids must be received by IOM at the address specified under ITB Clause 19.2.
