2. Service provider profile showing relevant services offered.
3. Service provider valid official registration certificate and/or a copy of the license from the local authority in Iraq while being specialized in health service field.
4. Qualification and experience of relevant professionals and technical personnel currently maintained. Please share a table of your permanently key employed staff (Name, Designation Qualification and No. of Years of Experience)
5. Track record and experience of the company in similar assignment including list of major clients served during last three years. (please list the year, client name, description of services and contract amount) and provide documentary evidence. Also provide testimonies for this purpose or references or contact details (name, phone number and email address) of minimum 3 top clients.
6. Proof of financial competency: 1) audited financial statements for the 2 two financial years 2018-2019 - 2019-2020, or 2) bank statement for the last two years, until April 2021, or 3) copy of the turnover of the last two financial years 2018-2019 - 2019-2020.
7. Other relevant Information.

Please note that the capacity of the email should not exceed **9MB** otherwise will be neglected by our server.

On the basis of the above information, the BEAC shall draw up the shortlist of Service Providers. Only short-listed Service Providers will be invited to submit technical and financial proposals.

Interested suppliers must submit all the requested documents listed above in this EOI Requirements. In the absence of specific documents as indicated, other documentation providing similar information may be accepted by the evaluation panel at its own discretion. In this regards the evaluation panel reserves the right to request additional information, documents or further clarification from one or multiple bidders.
