

REQUEST FOR EXPRESSION OF INTEREST

International Organization for Migrations (IOM) is an intergovernmental humanitarian organization established in 1951and is committed to the principle that humane and orderly migration benefits both migrants of society.

In the framework for **Durable Housing Rehabilitation**, IOM invites Expressions of Interest from Local Non-Governmental Organizations (NGOs) and Local Non-Profit Agency (NPA) for this project implementation.

- 1. The Application must be submitted via email to IRAQIPTENDERS@iom.int on 24th Mar 2019 at 11 AM. Late applications will not be considered, and documents capacity should be less than 9 Megabytes.
- 2. The application must be made in English language and in the format prescribed by IOM. All required information must be provided, responding clearly and concisely to all the points set out. Any application which does not fully and comprehensively address this request for expressions of interest may be rejected.
- 3. Application document should comprise the following:
 - a. Cover Letter
 - b. A copy of this Request for expression of interest duly signed on all pages by the NGO or NPA's authorized representative
 - c. License and the organization's profile with full CV and organization structure
- 4. Applications shall be evaluated in accordance with the following criteria
 - a. Proven track record of successful implementation of Rehabilitation of Cat 2 War damaged houses in this area, using the same methodology.
 - b. Technical Expertise on proposed project especially in the area of implementation, including staff and equipment capacity

Only eligible/qualified organizations based on the above shall be invited to participate in the bidding/tender process.

- Experience working with shelter cluster and shelter partners is required. The implementing partner should demonstrate knowledge and experience on war damaged house rehabilitation based on the shelter cluster guideline and humanitarian standard.
- 6. Applications may be modified or withdrawn in writing prior to the closing time specified in this EOI. Applications shall not be modified or withdrawn after the deadline.

PROJECT GOALS AND ENVISAGED OUTCOMES

- 1. To carry out to completion, Rehabilitation of War Damaged Houses in line with the Shelter Cluster Guidelines to serve 300HH in Beji, Salah Din, based on the needs of the family's shelter, keeping in mind cultural and socio-economic norms and practices.
- 2. To represent IOM and our donor for this project, OFDA, by strictly observing and adhering to humanitarian principles without preference for any ehtno-religious group, but prioritizing families of higher vulnerability i.e. PLW, FHH, YHH, Chronic Illness or Disability, Large family size, no source of income, and may require and additional verification using the Cash Working Group tool.
- 3. To deliver a well-executed and completed project to IOM by 30 June 2019 in line with the IP agreement to be signed once the organization is selected, or for a project duration of 9 weeks.

BACKGROUND AND RATIONALE

Following the cessation of hostilities in Beji area after the liberation by coalition forces, several families have begun to return to Beji areas and are living in desperate conditions in temporary housing as their houses have suffered significant damage from the occupation.

This project seeks to restore the houses for the most vulnerable 300HH, in line with the vulnerability criteria stipulated in the CWG tool, as preferred by the Shelter Cluster and to rebuild the houses of the families focusing on Major non-structural damage, basic household needs including kitchens, and lockable WCs, repairs to waterlines, sewer lines and electrical connections as well as connection to electrical points, installation of security doors or repairs where needed, installation of damaged doors and windows and repairs to floors as assessed for each family home.

An agency with experience in this area of implementation will be preferred, especially if they have experience working in Salah Din.

This is in line with IOM's and our donor's prioritization of the grand bargain commitment to the localization of aid by offering support, funding tools and expertise to the national responders (local NGOs) to increase their capacity, exposure, competence and reach.
