UN-CERF / IOM Uganda Project Evacuates 456 Stranded Congolese Asylum Seekers

As tens of thousands of Congolese have been fleeing into Uganda to escape ethnic clashes and human rights abuses since late 2017, at least 2,500 landed at remote fishing villages on the shores of Lake Albert. There they remained unacknowledged by the Uganda Government, uncounted in refugee statistics, and unreachable by humanitarian agencies.

To alleviate the plight of these asylum seekers, IOM Uganda worked with the Office of the Prime Minister, Marine Police and UNHCR to evacuate nearly 500 most vulnerable to accessible centres where they were picked up by UNCHR. This was part of the project funded by the United Nations Central Emergency Response Fund (UN-CERF)

EU / IOM support Kampala City Authority on Migrants

On 13 April, Kampala Capital City Authority (KCCA) held a consultative meeting on taking a coordinated approach to serving urban refugees and migrants.

The stakeholder meeting at Serena hotel was supported by IOM Uganda's Strengthening Social Cohesion and Stability in Slum Populations (SSCoS) project, which is funded by the European Union. In attendance were members of the diplomatic corps, development partners, United Nations agencies, NGOs dealing with migrants and refugees, and officials from the central and local governments.

CERF project trains MarinePolice unit

Funded by the UN Central **Emergency** Response Fund (CERF), IOM Uganda recently boosted the capacity of the Marine Police Force unit in the western district of Hoima. IOM trained eight Police officers in medical and search-and-rescue skills. and donated 400 life jackets and VHF radios to the MPF at Sebagoro landing site on Lake Albert. More than 80,000 Congolese have fled to Uganda since 01 January, many crossing Lake Albert. The Police will be better-equipped to answer distress calls.

He was treated in Nairobi hospital and returned to work in Juba — until war forced him to seek refuge in Uganda.
