The Need for the "Migrant Lives Matter" Project

Challenge & Solution

- National statistics offices ("NSOs") are at the forefront of SDG data collection efforts.
- Despite the philosophy of "Leave no one behind", the 169 targets place a heavy data collection burden on NSOs – especially those with limited resources and capabilities.
- IOM and Gallup to meet the challenge set out by the High-Level Panel by providing a system to measure migrant outcomes on a regional basis against core SDG themes.
- IOM and Gallup can implement the endeavor in a cost-effective way by using key metrics collected on an ongoing basis via the Gallup World Poll.
- A manifestation of the "data revolution."



Gallup World Poll Methodology



Surveys in over 140 countries annually since 2006, covering over 98% of the world's adult population.



Nationally representative samples of the adult population 15 years and older, with a sample size 1000 or greater per country.



Face-to-face interviews are used in all countries except those where telephone coverage represents at least 80% of the population or is the customary survey methodology.



Interviewed more than 1.5 million adults worldwide (164 countries to date).

Reporting

- Results for the world and nine key regions.
- Country case studies in those countries where there is a high proportionate percentage of migrants to nationals.


Limitations

- As a household survey, it excludes migrants who reside in group situations such as refugee or work camps.
- Some migrants may be unable to participate if they do not speak any of the languages offered in interviewing.






