Interested Bidders must submit the following information and documents together with the original of bid:

- 1) Official Bid (according to bid template Form-1, Form-2);
- 2) Specification of Bid (see template on page 20);
- 3) Schedule (Gantt chart) of the supply and distribution process (given as a separate template);
- 4) Vendor Information sheet (given as a separate template) – signed and stamped;
- 5) Code of Conduct for Suppliers (given as a separate template) – signed and stamped;
- 6) Bid Security equivalent (in the form of bank guarantee from a reputable commercial banking institution or from insurance company);
- 7) Bid Securing Declaration (in case Bid Security is not submitted);
- 8) Certificate of Registration from government agency in Ukraine or abroad;
- 9) Bidder’s Charter (if available);
- 10) Confirmations of Tax Identification Number and certificate of taxpayer, issued by respective government agencies in Ukraine or abroad;
- 11) Valid Government Permits/Licenses regarding the activity, related to the subject of the current tender (if applicable);
- 12) List of main contracts entered by the Company into for the last 2 years;
- 13) Financial statements (Statement of condition, Profit and Loss Account for 2017-2018 years);

- 14) Key customers' references;
- 15) Quality certificates for the Goods offered for delivery, proving the Goods' correspondence to the terms of reference of the present bidding documents and government standards of Ukraine.
- 16) General description of the supply and distribution process (Form-7);
- 17) Bid documents checklist (Form-8).

The bid shall be submitted in original and duplicate copies and should be received either by hand or through mail by the BEAC with office address at

not later than *17:00 (EET), 16.12.2019*, which is considered to be the deadline for bids submission.

Bids must be valid for a period of *60 calendar days* after the deadline of submission of the bids.

All bids must be prepared in USD VAT excluded.

The BEAC reserves the right to accept or reject any bid, and to annul the selection process and reject all bids at any time, without thereby incurring any liability to the affected bids.
