1. In a letter dated 11 November 2011, the Republic of Mozambique applied for membership in the International Organization for Migration. The letter and the Director General's reply, dated 15 November 2011, are reproduced in the annexes to this document.
2. In accordance with Article 2(b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Mozambique for membership and the rate of its financial contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.0033 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
3. An appropriate draft resolution will be submitted to the Council for consideration.

**LETTER DATED 11 NOVEMBER 2011 FROM THE MINISTER OF  
FOREIGN AFFAIRS AND COOPERATION OF THE REPUBLIC OF MOZAMBIQUE  
TO THE DIRECTOR GENERAL OF THE  
INTERNATIONAL ORGANIZATION FOR MIGRATION**

Sir,

I have the honour to refer to the relationship existing between the Government of the Republic of Mozambique and the International Organization for Migration (IOM).

My Government wishes to establish a closer relationship with your Organization and hereby applies for membership in the International Organization for Migration in accordance with Article 2, paragraph (b) of the IOM Constitution.

The Government of the Republic of Mozambique accepts the Constitution, and the amendments thereto of 24 November 1998, in accordance with its constitutional process and obligations resulting from membership. It also undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the OIM Council and Government.

A document formally presenting your Government's application for membership will be distributed to all Member States. You will receive a copy of it, together with further details concerning the Council session and the procedure for consideration of your country's application.
