SITUATION OVERVIEW

Since 2011, Libya has been in turmoil with different factions competing for power, resulting in a vacuum of governance and continued conflict with severe humanitarian ramifications. Following the eruption of clashes and escalation of conflict on 3 April 2019 in Tripoli, the country has spiraled into further disarray. Fighting has led to fatalities and injuries among the civilian population as well as an upsurge in the displacement of people. Migrants held in detention centres are particularly at risk and in need of protection due to their limited freedom of movement and inability to seek safety from shelling in residential areas.

Since the outbreak of the conflict, IOM has been providing emergency assistance to affected populations, including the provision of Non-Food Items (NFIs), food and clothing, primary healthcare, support for voluntary humanitarian return (VHR) and improvement of living conditions in detention centres. The IOM Displacement Tracking Matrix (DTM) has been instrumental in shaping the humanitarian response through tracking daily IDP figures and identifying the highest areas of needs. IOM has a continuous presence in Libya since 2006, with offices in Tripoli, Sabha, Qatroun and Benghazi and over 250 staff operating on the ground.

To respond to urgent and growing needs of migrants and IDPs in distress and trapped in the midst of conflict, IOM and its partners require **4.3 million USD** to increase their humanitarian interventions with a focus on improving access to life-saving assistance and services targeting the needs of the most vulnerable. All interventions are coordinated with other UN agencies and humanitarian organizations to ensure an efficient and coordinated response.

DIRECT ASSISTANCE \$2.8 M

Provision of Non-Food Items (NFIs)

12,000 migrants in detention centres and urban settings as well as **10,000 IDP families** will be provided with core relief items, including mattresses, blankets and hygiene kits.

Provision of food

5,000 migrants in detention centres will have access to cooked meals or dry rations and water, while **1,000 urban migrants** will be provided with food baskets.



WATER, SANITATION & HYGIENE \$800,000

4,000 migrants and IDPs in shelters as well as migrants in detention centres will benefit from the provision of safe drinking water and improved access to adequate sanitation through:

- Emergency water delivery for migrants;
- Maintenance of sanitation facilities, including desludging of septic tanks;
- Garbage collection, cleaning and vector control.



PROTECTION \$50,000

500 vulnerable migrants, in urban settings, migrants released from detention centres as well as **50 families hosting migrants** will be supported with relocation and coverage of costs related to shelter, food, transportation and medicine. Mobile teams will carry out vulnerability assessments and assistance will be tailored to the needs of each case. Beneficiaries will include vulnerable women, children, survivors of GBV and victims of trafficking.



HEALTH AND PSYCHOSOCIAL SUPPORT \$300,000

6,000 migrants in detention centres and urban settings and **IDPs** will have access to lifesaving primary health care services through:

- Provision of basic emergency primary health and reproductive health care services through the deployment of Rapid Response Teams to the conflict affected areas;
- Provision of medicines and basic supplies;
- Referral support for urgent and emergency cases;
- Provision of mental health and psychosocial support and referrals for the affected communities.



DISPLACEMENT TRACKING \$350,000

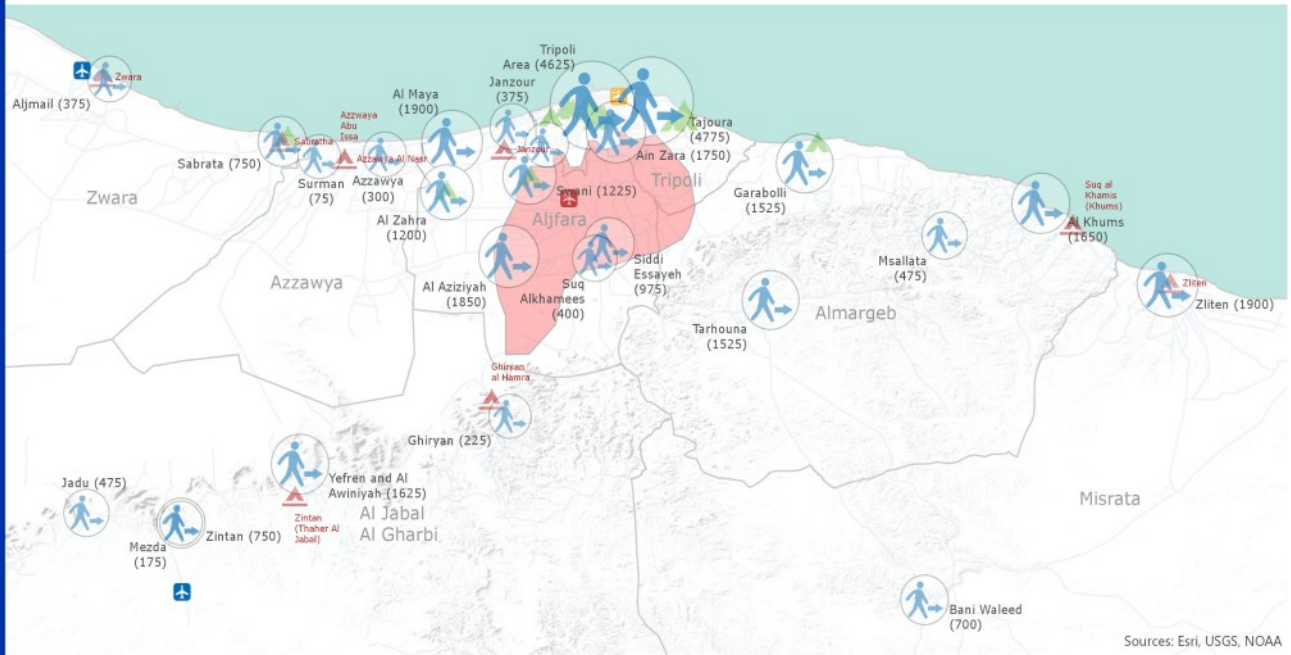
IOM's DTM will ensure the collection and provision of timely evidence-based information and reports on displaced populations to provide a common operating picture for all humanitarian actors working on the ground through:





- **Area assessment** to better understand the needs and vulnerabilities of affected the populations living in urban settings.
- **Multi sectoral location assessment**, including through data collection on the living conditions and needs of populations in collective IDP sites through baseline location assessments.
- **Verification of displaced populations** targeted through IOM interventions in urban areas and monitoring of needs, gaps and assistance provision in collective shelters covered by IOM, which is required for pre-distribution.
