

#### SITE UPDATES

#### **National CCCM Cluster**

Achieving an important milestone in the Cluster localization, capacity-building, and long-term transition strategy, the CCCM Cluster finalized plans for the handover of five Wau Collective Centers to local NGO Action for Development (AFOD). This transfer of responsibility without service interruption represents the culmination of over a year of Cluster capacity-building efforts.

Cluster provided support to CCCM partners on the ground in Kajo Keji, furnishing CCCM technical expertise and strengthening relationships with local authorities.

**PoCAA:** To mitigate the negative effects of the ongoing overcrowding of the PoCAA, CCCM-led decongestion operations continue with 1,800 IDPs awaiting relocation to newly built shelters. CCCM continues to pursue creative solutions to resolving the lack of space, conducting an empty shelter assessment and coordinating with S/NFI to design space-saving outdoor sitting areas to reduce congestion.

**Collective Sites:** Responding to community concerns over food distribution and registration issues, CCCM conducted an extensive messaging campaign on registration, lost cards, and procedures for reissuance.

**PoC:** In an effort to improve PoC living conditions and engage its responsibility for environmental stewardship, CCCM launched the next stage of an environmental improvement project with the expansion of pilot tree nurseries and planning for shade tree planting.

In response to insecurity within the PoC, CCCM continues to advocate for the civilian character of the site and coordinate partners in efforts to peacefully and proactively resolve disputes.

#### Malakal PoC

Continuing its work promoting nonviolent conflict resolution, CCCM inaugurated new members of Informal Mitigation and Dispute Resolution (IMDRM), drawing 200 participants from the community, Peace and Security Council, and sector representatives.

To ensure common infrastructure remains accessible to the entire PoC population, CCCM relocated 731 IDPs out of public spaces and into communal shelters. Camp management is mobilized neighboring block and zone leaders to facilitate their integration into the community.

In an effort to improve engagement between humanitarians, the host community, and displaced persons, CCCM launched a Communications with Community (CwC) strategy to include site committees, service and complaints desks and referrals, and information campaigns.

### Kajo Keji informal settlements

With the scale up in response to displacement in Kajo Keji and the arrival of new partners and coordination mechanisms, CCCM prioritized improving communication and mutual understanding between humanitarian partners and the community. CCCM campaign conducted а messaging on transparency, community-based camp management, and humanitarian accountability, working to avert misunderstandings and maintain good community relations.
