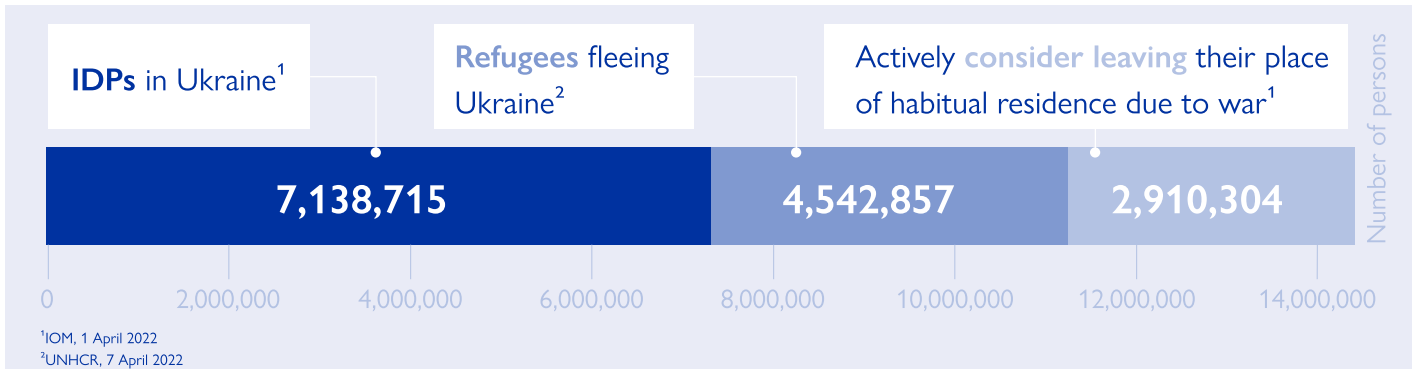

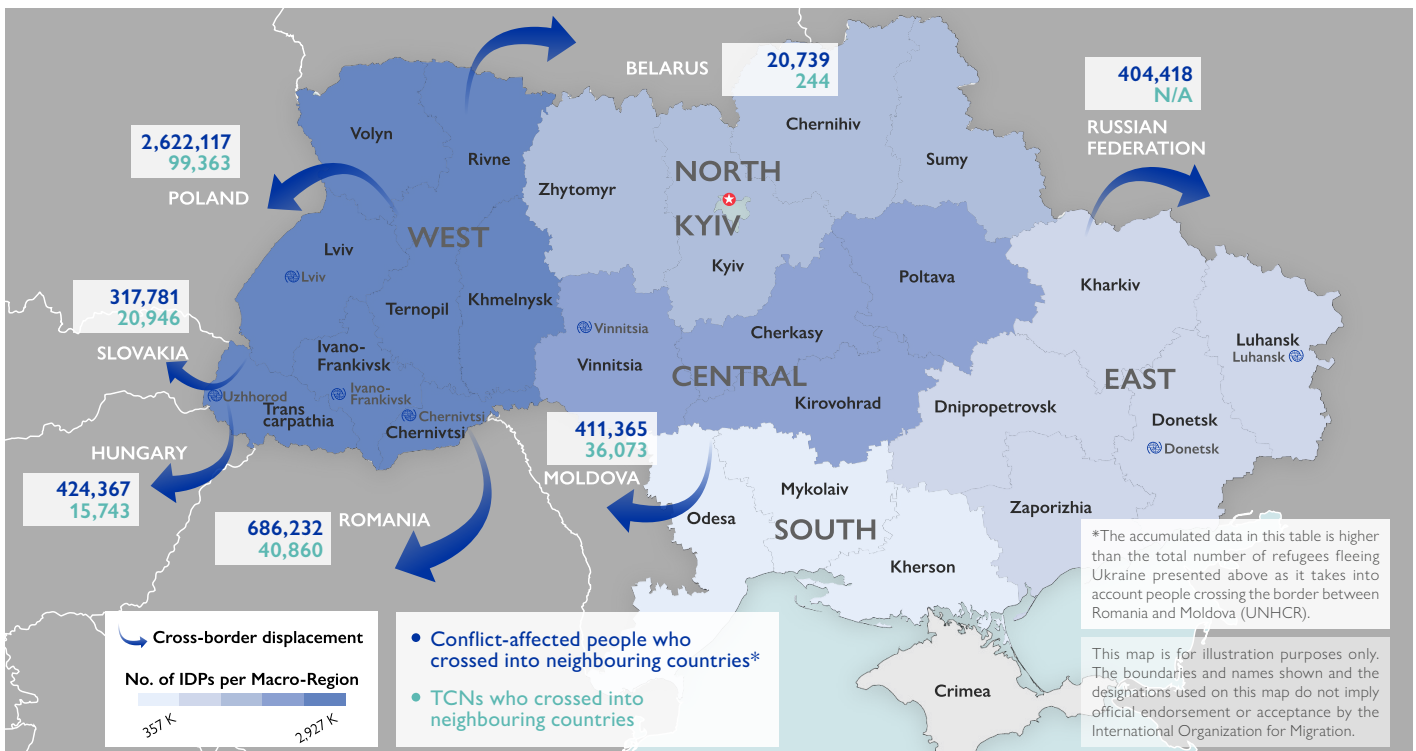

Since 24 February 2022, IOM has established presence in Uzhhorod, Lviv, Chernivtsi, Ivano-Frankivsk and Vinnytsia, in addition to its pre-existing field offices in Donetsk and Luhansk.

Warehouses have been set up in Uzhhorod, Berehove, Lviv, Chernivtsi, and Ivano-Frankivsk in Ukraine, as well as in Košice, Slovakia. IOM also avails itself of the Logistics Cluster's services, especially in Rzeszow (Poland), Lviv and Dnipro.

RECENT RESPONSE

	<p>More than 50,000 metric tons of humanitarian goods are currently in IOM's pipeline, with approximately 35 trucks arriving in Ukraine per week. Many of these goods are shipped from IOM's logistics hubs in Gaziantep (Turkey) and Greece, and transported through the 11 warehouses operated by IOM in Ukraine and neighboring countries. This is in addition to large in-kind donations from Canada, the UK and the US. IOM is also participating in inter-agency convoys to the most affected areas.</p>
	<p>Through its network of operational hubs and local partners, IOM is able to operate in all regions of Ukraine with the exception of Crimea. This includes the non-Government-controlled areas (NGCA) of Luhansk and Donetsk regions. 28 agreements have been signed with implementing partners since the start of the war.</p>
	<p>IOM published its second Ukraine Internal Displacement Report in early April. The nation-wide representative survey on displacement and movement intentions showed a total of 7.14 million estimated IDPs and an additional 2.91 million people who considered leaving their place of residence.</p>

	To help ensure the food security of Ukrainians affected by the war, IOM has distributed more than 3,500 food kits in Donetsk NGCA since 24 February as part of its first round of food provision. In addition, almost 20,000 boxes consisting of close to 2 million high-energy biscuits were delivered to the Odesa Humanitarian Center.
	As part of its Shelter response, IOM is launching its first two collective center repair mobile units in Zakarpattia Region this week. In addition, a six-storey former hospital has been identified as a possible collective center to free up space in schools and kindergartens before the start of the next school year – rehabilitation works are being explored.
	More than 10,000 individuals have been reached through IOM's cash-based intervention programming in Zakarpattia Region. More are being registered as this is being scaled up in five pilot regions. IOM is also looking into supporting people who were forced to return to their habitual place of residence after depleting their funds.
	Continuous support is being provided to the State Border Guard Service (SBGS), State Customs Service (SCS) and State Migration Service (SMS) of Ukraine to sustain their vital functions in migration and border management. In the last week, this included the delivery of 2,319 medical kits to the SBGS, 500 medical kits to the SCS and 100 medical kits to the SMS.
	IOM is providing support through information, assistance and advocacy to third-country nationals in Ukraine as well as to foreign nationals with family members in the country. To date, such support has been extended to more than 3,300 individuals.
	IOM assessed, advised, referred and assisted whenever possible in sixty cases with protection concerns . These included third-country nationals, children, people with disabilities and crisis-affected people who cannot leave their place of residence.
	A wide range of awareness raising materials related to safe migration, mitigation of risks of trafficking in persons, gender-based violence, MHPSS and the EU temporary protection directive continue to be disseminated through local and central authorities, IOM's channels, at BCPs and during the provision of humanitarian assistance. 28,500 leaflets have been distributed in the last week, bringing the total to more than 190,000.
	Eight tons of goods, including medicines and hygiene items, were donated by Pompiers de l'Urgence Internationale and distributed through IOM among IDPs and vulnerable members of local communities in Odesa region, as well as to the SBGS. This is part of IOM's cross-border operations from Moldova to reach Odesa region. Two more trucks are expected to arrive this week.

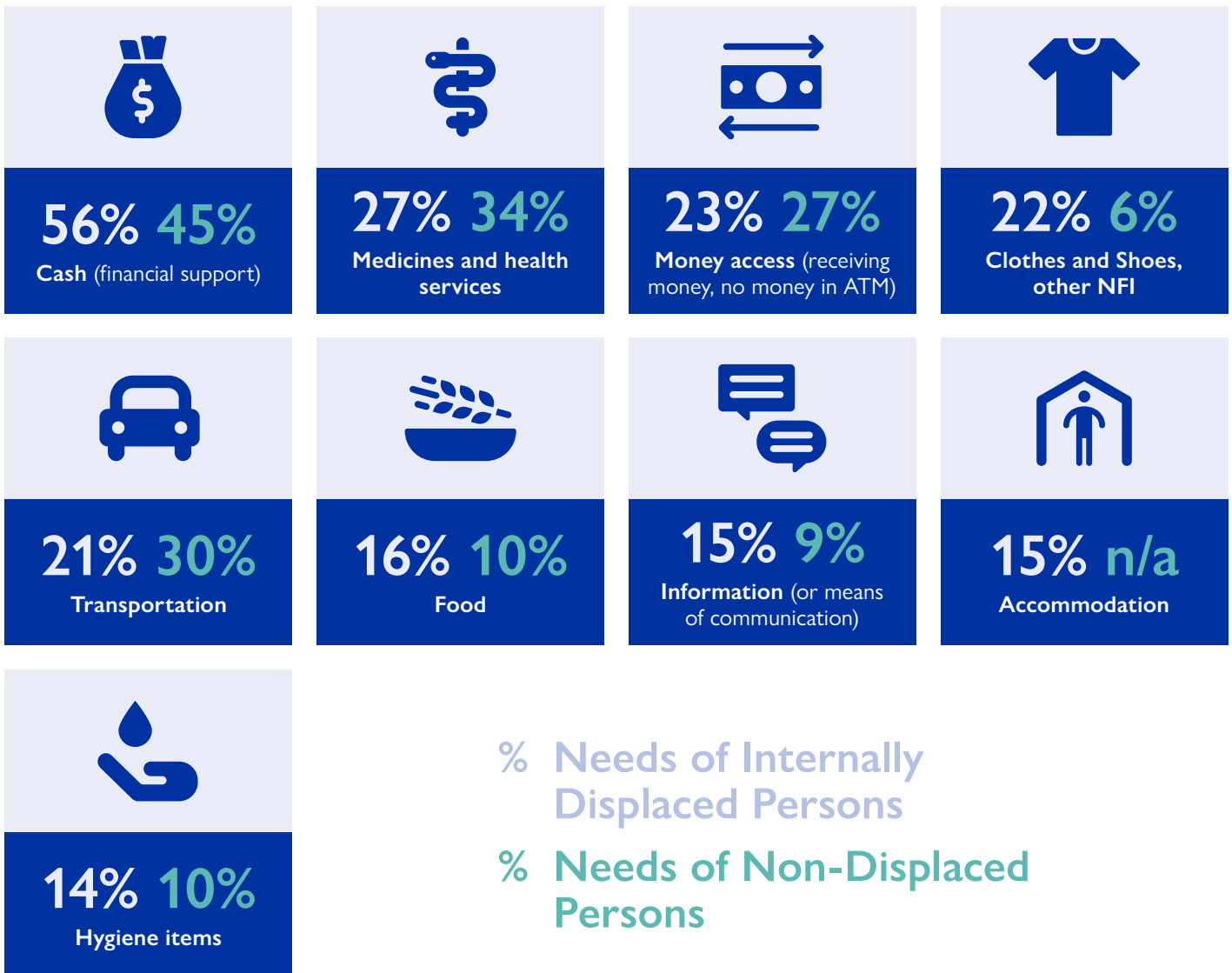
